- All paintings must be done on A3 size paper, and any medium (pastel, watercolors, etc.) can be used.
- The painting should not be framed.
- Your painting must be certified by the Principal as your own.
- The following details should be mentioned in the top left corner of the envelope.
 - o Contestant's name
 - Name of the school
 - o Grade
 - o Category (I or II)
- All submissions must be either mailed or delivered in person to the Task Force to Combat the Use of Poisonous and Dangerous Drugs at Navy Headquarters, Colombo 01, on or before 31st October 2024.
- Please ensure that the provided application form below is filled out and submitted along with all paintings.
- Chosen paintings will feature in publications by the Task Force to Combat the Use of Poisonous and Dangerous Drugs.

Animation Video Competition

- Students ranging from grade 10 to grade 13 and individuals from 19 to 30 years of age are eligible to take part.
- Animation videos can be submitted individually or in groups. (Groups must apply through a lead presenter).
- Any language can be used for animation videos be it Sinhala, Tamil or English.
- The maximum number of animated videos an individual / group can submit is one.
- When naming the video file (file name), students in the first category should use the lead presenting student's initials and the school's name. Presenters in the second category should use the main presenter's initials and National ID number.
- All information should be communicated through the lead presenter.
- Videos must begin with a 'full screen title' lasting around 5 seconds, displaying the following information.
 - o Name with initials of lead presenter
 - o Name of school (For first category only)
 - o Personal address of lead presenter (For second category only)
 - o Contact number (A whatsApp number is preferable)
 - o National Identity Card number of the lead presenter (For second category only)
- The video file format must be MP4.
- Animated videos should be between 15 and 50 seconds long.
- Visual content should be appropriate for all audiences.
- The content must adhere to national laws and must not include the following.
 - o Encouragement of unlawful behavior

- o Fueling of racial, religious, sexual, political, or other tensions
- o Provoking sexual arousal or creating a riot
- o Breach of laws or rights
- o Intrusion into someone's privacy
- o Deemed unsuitable by the Task Force to Combat the Use of Poisonous and Dangerous Drugs
- Animated videos must be original.
- The publication must not contain infringing commercial content (eg: music, video animation).
- Professional assistance cannot be sought in video creation.
- The content of the theme must be included in the animated video.
- Your creation should be uploaded to your Google drive and the link should be sent to this email <u>taskforceantinarcotics@gmail.com</u>.
 - o In the subject of the e-mail, the following information should be included
 - First category Name of lead presenter and name of school
 - Second category Name and National Identity Card number of the lead presenter
 - The application form given below should also be completed and submitted to the e-mail along with the link of the animation video.
- The closing date for submitting animated videos is 31st October 2024.
- The creator retains ownership of the animation video. However, the Task Force to Combat the Use of Poisonous and Dangerous Drugs reserves the right to reproduce, distribute, and display the video.
- All videos, photos and other aids (such as 3D images) used for animation and the original animation file (Project File) should be sent to the above e-mail address.
- A complete description of the software and additional plugins (3rd party plugins) used for the animation should be sent.
- The video you submit should be in Full HD (1920x1080) resolution or a similar size.
- Artificial intelligence-generated creations face rejection.

Judgment

- The competition will be judged by a panel of expert judges.
- The decision of the panel of judges is final.

- Attractiveness ability to attract the attention of the doer.
