- The license / registration certificate holder may nominate person(s) to submit and discuss on application for import or export license or registration as a dealer or end-user or for the premises on their behalf. The license / registration certificate holder should state the full name, Identity card / passport No. and position held for each person to act as an authorized officer. Signature of each person nominated in this connection must be authorized in writing.
- Applicant should inform the Authority of any theft, unexplained loss of suspicious activities relating to the Precursor Chemicals.
- Applicant is aware of that the Authority shall cancel the licenses of the applicant if the given particular are found to be false or inaccurate or any relevant data is suppressed.
- All documents should be provided and attached to the application.
- Original documents should be submitted with the certified copies.
- In addition to the above mentioned documents the Precursor Control Authority may request you to furnish further documents.
- Applicants are obliged to provide all information necessary to proof the relevant information and therefore are advised to submit only complete applications.
- E-Mail transmissions are not acceptable as supporting documents.
- Applicants should inform the Authority in case of disposal of the precursor chemicals or preparations thereof.
